2. Date of Birth Certificate.




3. Health Certificate, issued by the Competent Authority.
4. Permanent Resident Certificate.
5. Relevant Category Certificate (in case the candidate belongs to Reserved Category).
6. Certificate from General Manager, DIC concerned and Deputy Director, Employment concerned to the effect that no loan has been taken by the candidate under any Scheme.

In case any appointee fails to join within stipulated period of 21 days, his/her appointment shall be cancelled without any further notice.

The appointment shall be subject to the following conditions:-

- a) The appointee shall give an undertaking duly attested by a Judicial Magistrate to the effect that in case adverse report about his / her character and antecedents is received from the Inspector General of Police, CID, Jammu and Kashmir, to whom a reference shall be made by the Department, his / her appointment shall be deemed to be cancelled ab-initio and he / she shall have no claim on his / her appointment.
- b) The verification of qualification certificates / reserved category certificate (wherever applicable) from the concerned quarters / issuing authority.

The salary of the appointee shall not be drawn and disbursed unless a satisfactory report in respect of (a) & (b) above is received.
