As recommended by the J&K Service Selection Board, Srinagar, sanction is hereby accorded to the appointment of Shri Anil Kumar Sharma S/o Shri Madan Lal Sharma R/o Gurahmehtian, Hiranagar, Kathua as Warper-cum-Winder in PB-I Rs. 5200-20200+1900 (Grade Pay) in Handloom Development Department (District Cadre) Kathua, subject to the condition that:

- (a) The appointee shall report to the office of the Joint Director, Handloom Development Department, Jammu within a period of 21 days from the date of issuance of this order.
- (b) In case of failure of said appointee to join within the stipulated period, his appointment shall be deemed to have been cancelled without any further notice.
- (c) The appointee shall be allowed to join only on production of following certificates/documents in original which shall be verified subsequently from the concerned quarters by the Joint Director, Handloom Development Department, Jammu:-
 01. Academic/Technical Qualification Certificates.
 02. Date of Birth Certificate/Matriculate.
 03. Health Certificate, issued by the Competent Authority/CMO.
 04. Permanent Resident Certificate issued by Competent Authority.
 05. Relevant Category Certificate (in case the candidate belongs to Reserved Category).
 06. Certificate from General Manager, DIC concerned and Deputy Director, Employment concerned to the effect that no loan has been taken by the candidate under any Scheme.
 07. If on verification, the certificates produced by the appointee are proved fake or forged, the appointment shall be cancelled abinitio.

The appointment of the above said candidate as Warper-cum-Winder shall further be subject to the following conditions:

- (i). The appointee shall give an undertaking duly attested by a Judicial Magistrate to the effect that in case of adverse report about his character and antecedents is received from the Inspector General of Police, CID, Jammu and Kashmir to whom a reference shall be made by the Department, his appointment shall be deemed to be cancelled ab-initio and he shall have no claim on his appointment.
- (ii). If on verification of certificate(s) produced by the appointee are proved to be fake or forged, the appointment shall be cancelled ab-initio.
- (iii). The salary of the appointee shall not be drawn and disbursed unless a satisfactory report in respect of (i) & (ii) above are received in his favour.
- (iv). The appointment of the said candidate shall be governed by the "NPS" as per SRO 400 of 2009 dated 24-12-2009.
- (v). The appointee shall be on probation for a period of two years.
