The appointee shall report to the office of the Asstt. Director, Handloom Dev.Deptt; Bandipora within a period of 21 days from the date of issuance of this order. The appointee shall be allowed to join only on production of following certificates/documents in original which shall be verified subsequently from the concerned quarters :-

1. Academic/Technical Qualification Certificates.
2. Date of Birth Certificate.
3. Health Certificate, issued by the Competent Authority.
4. Permanent Resident Certificate.
5. Relevant Category Certificate (in case the candidate belongs to Reserved Category).
6. Certificate from General Manager, DIC concerned and Deputy Director, Employment concerned to the effect that no loan has been taken by the candidate under any Scheme.

In case the appointee fails to join within stipulated period of 21 days, his appointment shall be cancelled without any further notice.


The appointment shall be subject to the following conditions :-

- (a) The appointee shall give an undertaking duly attested by a Judicial Magistrate to the effect that in case adverse report about his character and antecedents is received from the Inspector General of Police, CID, Jammu and Kashmir to whom a reference shall be made by the Department, his appointment shall be deemed to be cancelled ab-initio and he shall have no claim on his appointment.

- (b) The verification of qualification certificates/reserved category certificate (wherever applicable) from the concerned quarters/issuing authority.

The salary of the appointee shall not be drawn and disbursed unless a satisfactory report in respect of (a) & (b) above is received.


